THE CORPORATION OF THE CITY OF GREENWOOD

2019 and 2020 Tax Exemption BYLAW No. 934, 2018

A Bylaw to exempt certain properties from taxation for the years 2019 and 2020.

Council of the City of Greenwood, in an open meeting assembled, enacts as follows:

- 1. This bylaw may be cited as the "2019 and 2020 Tax Exemption Bylaw No. 934, 2018".
- The following properties, being or including areas surrounding buildings set apart and in use for public worship, are exempt from taxation for 2019 and 2020.
 - (a) Lot 5, Block 7, Plan 34, District Lot 711, Similkameen Div. of Yale Land District, (Roll 00160.000) held by the Anglican Church;
 - (b) Lot 6, Block 7, Plan 34, District Lot 711, Similkameen Div. of Yale Land District, Portion E 1/2 Block 7, (Roll 00160.010), held by the Anglican Church;
 - (c) Lot 1, Plan 2806, District Lot 711, Similkameen Div. of Yale Land District, (Roll 00226.000), held by the Roman Catholic Bishop of Nelson;
 - (d) Lot 2, Plan 2806, District Lot 711, Similkameen Div. of Yale Land District, (Roll 00226.010), held by the Roman Catholic Bishop of Nelson;
 - (e) Parcel A, Block 36, Plan 34, District Lot 711, Similkameen Div. of Yale Land District, Portion (KE4056), (Roll 00267.005), held by the Trustees of the Evangel Chapel.
- 3. Parcel A, (DD KN83911) Block 14, Plan 21, District Lot 597, Similkameen Div. of Yale Land District, (Roll 00101.025), held by the Greenwood Heritage Society, not being operated for profit or gain and owned by a charitable organization supported in whole or in part by public funds and used as a museum, is exempt from taxation on both land and improvements for 2019 and 2020.
- 4. Lots 10 and 11, Block 5, Plan 21, District Lot 597, Similkameen Div. of Yale Land District, (Roll 00021.001), being the site of a municipal building, are exempt from taxation on both land and improvements for 2019 and 2020, excluding the bar portion occupied by the Royal Canadian Legion Branch 155.

- 5. Lots 18 and 19, Block 7, Plan 21, District Lot 597, Similkameen Div. of Yale Land District, (Roll 00039.000), held by the Greenwood Temple Society, not being operated for profit or gain and owned by a charitable organization supported in whole or in part by public funds are exempt from taxation on both land and improvements for 2019 and 2020.
- 6. Lots 1 9, Block 6, Plan KAP21, and Lot A Plan KAP22200 of District Lot 597, Similkameen Div. of Yale Land District (Rolls 00026.000, 00026.020, 00026.040, 00027.000, 00028.000, 00028.025) being used as a parking lot by the City of Greenwood and leased from Anwar Tantawy, are exempt from taxation on both land and improvements for 2019 and 2020.
